Having regard to the Saudi Food and Drug Authority Law promulgated by the Royal Decree No. M/6 on 25/1/1428 AH. and its Implementing Regulation issued by the decision of the Board of Directors of the Authority No. (7/7/1428) on 25/7/1429 AH.

Having regard to the Cosmetic Products Law promulgated by the Royal Decree No. M/49 on 18/6/1429 AH. and its Implementing Regulation issued by the decision of the Board of Directors of the Authority No. (11/13/1436) on 25/7/1429 AH.

Having regard to the paragraph (Third) by the decision of the Board of Directors of the Authority No. (11/13/1436) on 16/1/1437 AH. Authorizing the Chairman of the Board of Directors of the Authority to approve the classification of violation and penalties established in accordance with article Thirty-Five, paragraph 1, of the Cosmetic Products Law and as required by the Labour Service

Decide the followings:

Firstly: Approve the Violations Schedule of the Cosmetic Products Law, its Implementing Regulation and the penalties prescribed for it as attached to this decision.

Secondly: This decision shall be effective from the date of its approval.

Thirdly: This decision shall be communicated to those required to enforce and act upon it.

First Chapter: Trading Violations

Trading violations include stages that cosmetic product goes through until it reaches the consumer, including import, export, manufacture, preparation, installation, processing, packaging, processing, storage, transport, possession, marketing, distribution, supply for sale, sale and distribution free of charge. Therefore, a penalty is included for each establishment, depending on its role in the supply chain of the cosmetic product:

* The penalty for trading violations shall be imposed on the lister of the product, whether the importer or the company producing the product, has a legal entity in the Saudi Arabia and it proved that the product was supplied through the lister of the product

**The above penalties are imposed on distribution warehouses that provide proof of supply of the product from an importer, producer or other distributor. If no proof is provided, they shall be punished as an importer, producer or other distributor according to the penalties of the importer\lister that are listed in the table above.

*** Penalties are imposed on retail outlets if they have proof of product supply from a distributor, importer, producer or other retailer. If no proof is provided, the retailer shall be punished as an importer or producer according to the penalties of the importer\lister that are listed in the table above.
